CENTRAL BASIN REGIONAL DISADVANTAGED COMMUNITIES INCENTIVE PROGRAM

I. BACKGROUND

The Central Basin Watermaster Service Area overlies about 227 square miles of the Central Groundwater Basin ("Central Basin" or "Basin") and includes a population of more than 2 million people. (See Exhibit A.) Groundwater from the Basin provides a substantial portion of the water supply needed by residents, businesses, and industries in the area overlying the Central Basin.

Beginning in the 1960's, Central Basin has been managed as an adjudicated groundwater basin pursuant to a court ordered judgment that has been amended three times. The Third Amended Judgment ("Judgment") established a new plan for the Central Basin and for the first time established water storage rights.

This new plan adds flexibility to allow the purchase, storage and use of water when it makes the most economic sense, and divides over 330,000 acre-feet of groundwater storage capacity above that of existing water rights in the Central Basin. The Judgment determined that of the available storage space, 110,000 acre-feet would be set aside for use by the Water Replenishment District of Southern California ("WRD") as a Basin Operating Reserve and that water rights holders may store 108,750 acre-feet through individual storage allocations. The remaining 111,250 acre-feet represent the Community Storage Pool, which includes an allocation for Disadvantaged Communities through the Regional Disadvantaged Communities Incentive Program ("RDCIP" or "Program"). With the State of California in addition to regional water agencies stressing the importance of careful management of groundwater basins including storage, any and all available storage in the Central Basin is extremely valuable.

A Disadvantaged Community, as defined by the Judgment, means an area served by a "Water Purveyor and that consists of one or more contiguous census tracts which, based upon the most recent United States Census data, demonstrates a median household income which is less than eighty percent (80%) of the median household income for all Census Tracts within the State of California." (Judgment, pp. 8-9.) Portions of several communities in the Central Basin are classified as Disadvantaged Communities and will be eligible for the RDCIP.

II. DEVELOPMENT OF THE RDCIP

On June 29, 2014, the Central Basin Water Rights Panel retained an independent consultant team ("Consultant") to develop the RDCIP. Under the Judgment, the Consultant was required to provide the Central Basin Water Rights Panel with a detailed RDCIP within 90 days of the Consultant's retention, which must be submitted to the

Court for its review and approval. Despite good faith efforts to develop the RDCIP within the original timeline provided by the Judgment, the public interest in the RDCIP coupled with the complexity and importance of the Program, has resulted in the request for additional time. The Central Basin Water Rights Panel requested a 180-day extension from the Court in November 2014 and the Court granted a hearing on the request currently scheduled for February 4, 2015.

During the development of the RDCIP and assisted by an Ad Hoc Committee (Exhibit B) chosen by the Central Basin Water Rights Panel, the Consultant conducted two well-attended public workshops to solicit stakeholder input and ideas. The workshops were held on August 21, 2014 in Cudahy and September 4, 2014 in Norwalk.

After three meetings with the Ad Hoc Committee where the draft RDCIP was discussed and revised, the Ad Hoc Committee and the Consultant presented drafts to the Central Basin Water Rights Panel on December 11, 2014 and on January 8, 2015. The Central Basin Water Rights Panel provided additional feedback and direction, which resulted in a revised version. The draft RDCIP will be submitted to the Court for approval after a period of public review and comment.

All documents related to or created during the development of the RDCIP were made available on the Central Basin Watermaster website at www.cbwatermaster.org and are attached as Exhibit C.

III. RDCIP PROGRAM INFORMATION

The Judgment provides the RDCIP with a second priority right to occupy up to 23,000 acre-feet within the Community Storage Pool. (Judgment, Section IV.E.2.) This storage must be made available to or for the benefit of Disadvantaged Communities within the Central Basin. (Judgment, Section II.H.) Regional Disadvantaged Communities may not have the necessary staff or resources to take advantage of the RDCIP or to secure other much needed funding and grant opportunities for water supply projects. The RDCIP encourages the leveraging of resources to assist in securing funds at the State and local level to supplement those available through the RDCIP or otherwise. The Central Basin Water Rights Panel shall ensure that the application process is not burdensome or costly. Therefore, the application process will be limited to a simple, standardized application developed by the Central Basin Water Rights Panel.

IV. DEFINITIONS

- A. Central Basin Water Rights Panel The constituent body of Watermaster consisting of seven (7) Parties elected from among the parties holding Allowed Pumping Allocations as provided in Section II (B) of the Judgment.
- B. Community Storage Pool The cumulative quantity of Adjudicated Storage Capacity allocated to Community Storage is 111,250 acre-feet.

- C. Disadvantaged Community means any area that is served by a Water Purveyor and that consists of one or more contiguous census tracts which, based upon the most recent United States Census data, demonstrates a median household income which is less than eighty percent (80%) of the median household income for all Census Tracts within the State of California. (Judgment, pp. 8-9.)
- D. Party means any Party (and successors in interest) to Central and West Basin Water Replenishment District, etc., v. Charles E. Adams, et al., No. 786,656 (1965).
- E. Project Area means the subject area of an application submitted by a Disadvantaged Community or coalition of Disadvantaged Communities. The subject area may consist of a variety of the following; subwatershed, watershed, multiple subwatersheds or watersheds, community, or communities.
- F. Storage Panel means the bicameral constituent body of Watermaster consisting of (i) Central Basin Water Rights Panel and (ii) the Board of Directors of WRD.
- G. Water Purveyor means a Party (and successors in interest) which sells water to the public, whether a regulated public utility, mutual water company or public entity.

V. DISADVANTAGED COMMUNITY

RDCIP benefits are limited to Disadvantaged Communities located within the Central Basin. (Judgment, Section II.H.) Accurate GIS census tract mapping of Disadvantaged Communities shall be provided by the Central Basin Water Rights Panel, and shall be made available through the Central Basin Watermaster website within 90 days of the availability of decennial U.S. Census data. Following each decennial census, the Central Basin Water Rights Panel shall identify Disadvantaged Communities in the Central Basin. It shall be the responsibility of the applicant to demonstrate eligibility based on the Disadvantaged Communities identified by the Central Basin Water Rights Panel. Eligible Disadvantaged Communities are encouraged to apply to the RDCIP.

VI. OUTREACH PROGRAM

In order to ensure a full and robust participation by all qualifying Disadvantaged Communities to the maximum extent possible, the Central Basin Water Rights Panel may develop an outreach program to assist Disadvantaged Communities with the application and reporting requirements of the RDCIP as appropriate.

VII. RDCIP WATER STORAGE ALLOCATION

The Judgment provides the RDCIP with a second priority right to occupy up to 23,000 acre-feet within the Community Storage Pool. This storage must be made available to or for the benefit of Disadvantaged Communities within the Central Basin. The Central Basin Water Rights Panel may allocate all or a portion of water storage to one or more qualifying entities in order to effectuate the highest benefit to Disadvantaged Communities in the Central Basin. The 23,000 acre-feet of available storage will not be divided among the identified Disadvantaged Communities, but will instead be allocated by the Central Basin Water Rights Panel in a manner that will provide the benefit to all of the Disadvantaged Communities in the Central Basin.

A. RDCIP Water Storage Application Requirements

1. Required Contents of Application:

A Party to the Judgment or a group of entities, which includes at least one Party to the Judgment, may submit an application to the Central Basin Water Rights Panel to receive a water storage allocation. An applicant must disclose in its application all participants of the proposed water storage allocation, state the total amount of storage space they are seeking, and estimate the proposed duration of the proposed water storage allocation. Applications shall also include a timeline with designated milestones and corresponding progress reports.

2. Central Basin Water Rights Panel Determination:

Central Basin Water Rights Panel shall make the determination of which applicants shall receive a water storage allocation and the size of the allocation to be granted. The Central Basin Water Rights Panel shall make such determination taking into consideration which allocation(s) will provide for the greatest benefit to the maximum number of Disadvantaged Communities pursuant to an objective evaluation of the application. The Central Basin Water Rights Panel will establish an evaluation process based upon information the applicant provides using a standardized format provided by the Central Basin Water Rights Panel.

Potential factors that <u>may</u> be considered by the Central Basin Water Rights Panel to objectively rank and evaluate applicants for RDCIP water storage allocations are listed below and are not listed in any specific order. The Central Basin Water Rights Panel may also consider other factors it deems necessary:

a. The ratio of Disadvantaged Community census tracts located within the proposed project area in the application for storage in comparison to the total census tracts in that same project area;

- b. Disparity between the cost of water service provided within the project area and the median household income by the ratepayers within said project area;
- c. Existing infrastructure needs of the project area;
- d. Number of water purveyors providing water service to the project area;
- e. Amount of allocated water rights;
- f. Working relationship between community and water purveyor;
- g. Applicant is in good standing and current on all Watermaster fees and replenishment assessments;
- h. Analysis or explanation of the type and value of the benefit to a Disadvantaged Community or group of Disadvantaged Communities; and
- i. Any other objective factors the Central Basin Water Rights Panel deems appropriate.

Based on the information provided, the Central Basin Water Rights Panel shall designate priority ranking for each applicant.

The Central Basin Water Rights Panel shall determine the duration of each storage allocation based on the information provided in the application, however for the duration prescribed, the storage allocation is not subject to revocation in the event a qualifying Disadvantaged Community experiences a change in status based upon the most recent Census data. In the event storage project milestones are not met, storage is leased or resold without express permission from the Central Basin Water Rights Panel, or gross negligence, fraud, or misuse is determined by the Central Basin Water Rights Panel to have occurred, awarded storage may be revoked by a supermajority vote of the Central Basin Water Rights Panel. A supermajority consists of two-thirds of the total sitting membership of the Central Basin Water Rights Panel. The Central Basin Water Rights Panel may develop additional project approval parameters and may make additional allocations as RDCIP storage space becomes available.

B. Storage Panel Review

When required by the Judgment, the Storage Panel may review water storage construction projects proposed under this Program.

C. Recording of Storage and Use

All entities allocated water storage through the Program must properly account for the amounts of all water stored and extracted and submit a report to the Watermaster and Central Basin Water Rights Panel on a monthly basis and not more than two months in arrears. Any adjustments to the monthly submittals shall be submitted to the Watermaster and Central Basin Water Rights Panel in a timely manner for consideration in the preparation of the Watermaster's annual

assessment package. Within one year following the end of the fiscal year, an annual reconciliation shall be performed of storage and extraction. Production reports must include a statement under penalty of perjury that production was for the benefit of a Disadvantaged Community (or group of Disadvantaged Communities).

VIII. CENTRAL BASIN REGIONAL DISADVANTAGED COMMUNITIES INCENTIVE PROGRAM BANK ACCOUNT

A Central Basin Regional Disadvantaged Communities Incentive Program account ("RDCIP Bank Account") shall be established for the sole use and benefit of the Central Basin Disadvantaged Communities. The RDCIP Bank Account shall be separate and not commingled with any other financial or trust accounts of the Watermaster or Central Basin Water Rights Panel. The RDCIP Bank Account shall be a restricted account until such time as the account monies total one million dollars; thereafter a trust account will be utilized. The RDCIP Bank Account shall be overseen by the Watermaster and will be used to benefit the Disadvantaged Communities and to fund an independent annual financial and end-use audit of the RDCIP. RDCIP Bank Account funds will be made available for Disadvantaged Community drinking water supply related infrastructure or projects, as detailed below.

A. Allocation of RDCIP Bank Account Funds

RDCIP Bank Account funds shall be allocated to those Disadvantaged Communities that submit an application to the Central Basin Water Rights Panel. Based on the information provided, the Central Basin Water Rights Panel shall determine which RDCIP Bank Account applicants are awarded funds and the amount awarded to each. The evaluation will be based upon information the applicant provides using a standardized format provided by the Central Basin Water Rights Panel. The Central Basin Water Rights Panel shall take into account the number of Disadvantaged Community census tracts located within the applicant's project area. Collaborative efforts between multiple agencies and industries are encouraged to apply for and develop drinking water supply related infrastructure and projects that benefit Central Basin Disadvantaged Communities.

Allocations made must be used to fund drinking water supply related infrastructure and projects that benefit Disadvantaged Communities as defined by the Judgment. Applications shall include a timeline with designated milestones and corresponding progress reports. The Central Basin Water Rights Panel shall review project progress and awarded funds may be revoked by a supermajority vote, receiving two-thirds of the total sitting membership of the Central Basin Water Rights Panel, at any time in the event that milestones are not met, or gross negligence or misuse is determined by the Central Basin Water Rights Panel to have occurred. Additional Central Basin Water Rights Panel

approval must be obtained prior to use of any RDCIP Bank Account funds not included in the approved RDCIP Bank Account application, as agreed to between the Central Basin Water Rights Panel and the applicant. In the case that it is found that RDCIP Bank Account funds were used in an improper manner, the entity that received those funds must repay such funds to the RDCIP Bank Account.

B. Drinking Water Supply Related Infrastructure and Projects

An identified Disadvantaged Community may submit an application to the Central Basin Water Rights Panel for use of RDCIP Bank Account funds. The Central Basin Water Rights Panel will review the applications and award funds to applicants that demonstrate that their drinking water supply related infrastructure and/or project would benefit one or more Disadvantaged Communities.

- 1. Drinking water supply related infrastructure and projects include but are not limited to the following activities:
 - a. Develop or rehabilitate potable water supply distribution systems,
 - b. Cleanup of naturally occurring or human produced contamination of groundwater for direct potable water supply distribution or infiltration,
 - c. Improve quality of stormwater through infiltration,
 - d. Develop and/or expand recycled water programs,
 - e. Increase groundwater replenishment, or
 - f. Develop and/or expand low impact development projects.
- 2. All drinking water supply related infrastructure and cleanup projects must clearly demonstrate a benefit to one or more Central Basin Disadvantaged Communities.

C. Audit and Annual Reports

1. RDCIP Account Audit

The RDCIP Bank Account shall be audited annually as part of the Central Basin Water Rights Panel audit with special instructions. The audit findings shall be included in the RDCIP annual report. The Central Basin Water Rights Panel's independent auditor shall possess proper education and training to evaluate trust administrative and operational functions. The account auditor shall be paid at a rate not to exceed the customary professional fee for work of this nature. All RDCIP projects may be subject to audit. Any Disadvantaged Community that accesses funds in the RDCIP Bank Account shall maintain all records pertaining to any project funded with those funds for at least five (5) years after completion of that project.

2. Annual Reports

Each applicant that has received a water storage allocation or a disbursement of RDCIP Bank Account funds shall submit an annual report to the Central Basin Water Rights Panel using a simple, standardized report form on the use of such storage, funds, and/or the status of the drinking water supply related infrastructure and project. Annual reports shall include production records and a signed statement certifying its contents. Additional Central Basin Water Rights Panel approval must be obtained prior to use of any RDCIP Bank Account funds not included in the approved RDCIP Bank Account application, as agreed to between the Central Basin Water Rights Panel and the applicant. In the case that it is found that RDCIP Bank Account funds were used in an improper manner the entity must repay such funds to the RDCIP Bank Account.

D. Central Basin Water Rights Panel Use of RDCIP Funds for Program Administration

RDCIP funds may be used for Program Administration. Watermaster or Central Basin Water Rights Panel general funds shall not be used for Program Administration.

IX. WATER STORAGE USE

The RDCIP is given a second priority right to the storage in the Community Storage Pool. Once the storage is allocated to an applicant that applicant may store and pump water from the Community Storage Pool in accordance with the Judgment, but subject to any limitations or conditions that the Central Basin Water Rights Panel may impose in connection with the granting of an application for use of the storage.

X. WATER STORAGE RECOVERY

Water Storage recovery and replenishment under the RDCIP must be conducted in accordance with the withdrawal and refill requirements of the Judgment.

A. Limit on Storage

Each party to the Judgment may not cumulatively have in storage at any time Stored Water totaling more than two hundred percent (200%) of that party's Allowed Pumping Allocation. (Judgment, Section IV.F.)

Any quantity of water held in the Community Storage Pool for a term greater than ten (10) consecutive years shall be assessed an annual water loss equal to 5% of the lowest quantity of water held within the party's Community Storage Pool

account at any time during the immediately preceding ten-year period. (Judgment, Section IV.E.6.)

B. Avoidance of Material Physical Harm

The storage and recovery of water from the Community Storage Pool through the RDCIP shall not create a material physical harm, or imminent threat thereof, to the Central Basin as defined by the Judgment. (Judgment, p. 10.)

XI. WATER QUALITY

Water storage under the RDCIP must not cause or contribute to a violation of any applicable water quality objective, standard, criteria or drinking water standards.

XII. ANNUAL REPORT TO THE COURT

The status of the RDCIP shall be included as part of the Watermaster's annual report to the Court. The Central Basin Water Rights Panel shall give notice and allow for comment prior to the submittal of the annual report to the Court.

XIII. AMENDING THE RDCIP

The Central Basin Water Rights Panel shall have the ability to invoke a review of the RDCIP and if necessary propose amendments to better achieve the RDCIP's purpose to benefit Central Basin Disadvantaged Communities. Amendments made by the Central Basin Water Rights Panel shall be presented to the Court for review and approval.

Central Basin Boundary Map



QUICK FACTS ABOUT THE DEVELOPMENT OF A CENTRAL BASIN REGIONAL DISADVANTAGED COMMUNITIES INCENTIVE PROGRAM

A new and important program is being developed in order to benefit our community. A first of its kind anywhere in the State, the Regional Disadvantaged Communities Incentive Program ("RDCIP") was specifically created for the benefit of the Central Basin's disadvantaged communities. This new program allocates water storage rights to those communities that need it most and that otherwise may not have the resources to access it.

In 2013, a court issued a judgment granting more flexibility and localized management of the Central Groundwater Basin. This new plan allows for the purchase, storage and use of water when it makes the most economic sense and will divide over 330,000 acre-feet of groundwater storage capacity in the Central Basin.

An important component of this judgment is the RDCIP that allocates 23,000 acre-feet of storage from the Community Storage Pool for the use or benefit of disadvantaged communities. While the judgment does provide guidance and a purpose for the program, it leaves it to the region's stakeholders to decide how best to set up and implement the program.

All stakeholders and interested parties are encouraged to provide input into the development of the program.

Facts from the Judgment:

- 23,000 acre-feet of storage will be made available to cities for the benefit of disadvantaged communities within the Central Basin;
- A disadvantaged community means an area served by a water purveyor with one or more contiguous census tracts based on the most recent U.S. Census data and with a median household income less than 80% of the median household income in the State of California;
- The RDCIP must be developed within a 90 day timeframe (October 27, 2014 completion date). The Water Rights Panel will present the final RDCIP to the Court for approval on or before December 23, 2014;
- The Water Rights Panel will administer, through the General Manager of the Water Replenishment District of Southern California, the RDCIP and insure that the program benefits regional disadvantaged communities.
- The status of the program will be included as part of the annual report to the Court.





The Central Basin Water Rights Panel directed that the Bank Account and assessment fee be removed from the draft RDCIP at its December 12, 2014 meeting, but restored the Program's Bank Account at its January 8, 2015 meeting.
